<sup>\*</sup> **“All You Can Eat” Services** -- The monthly recurring charge will entitle the customer to unlimited direct dialed station interstate and intrastate long distances calls for residential voice only. If it is determined that usage is not consistent with residential voice applications, such as for Internet access services, commercial facsimile or auto-dialing, call forwarding, three-way calling, resale, telemarketing or other non-residential uses, Peoples may immediately suspend, restrict or cancel the customer’s service without prior notice and assess an additional \$20 monthly recurring charge for each month in which such usage occurred. Incidental internet and other data usage is permitted, provided however, that any usage in excess of 5,000 minutes per month shall be presumed to be not consistent with residential voice applications and shall be subject to the conditions stated above.
