Attached for filing please find proposed tariff changes for Peoples Telecommunications, LLC. The filing increases the single line business local exchange rate \$0.25 per month to \$20.25. The filing also increases the single line residential local exchange rate \$1.65 per month to \$18.65. Twenty five cents of the increase is to reflect the statewide affordable rate as determined by the Commission in Docket No. 17-GIMT-008-GIT. The remaining \$1.40 of the increase is to meet the FCC's rate floor minimum.

LOCAL EXCHANGE SERVICES

A. LOCAL ACCESS

- 1. This Tariff is subject to and governed by the General Rules and Regulations, which parts as they now exist or as they may be revised, added to or supp0lemented by superseding pages or issues, are made a part of this Tariff.
- 2. The schedules of monthly rates for Local Access Service applicable within the various exchange areas for the services offered therein are shown in this Tariff. Local Access Service as offered in this Tariff is provided by serving central office line equipment and all outside plant facilities needed to connect the serving central office with the customer premises. These facilities up to and including the Network Interface Device are Company-provided and maintained and, with the installation of inside wire and outlet of a working service point, provide access to and from the telecommunications network for message toll service and for local calling by the customer.
- 3. The monthly Local Access Rates showing in this Tariff are payable in advance and entitle the customer to access other local exchange customer through company-owned facilities.
- 4. Rate Grouping

For purposes of application of monthly rates for local access serviced three (3) rate groups have been established as follows:

Business, 1-Party	\$20.25	(CR)
Residence, 1-Party	\$18.65	(CR)
Semi-Public, 1-Party	\$20.25	(CR)
PRX Trunk Line	\$20.25	(CR)

5. When a multi-line business customer uses their own equipment to channelize local service at a DS-1 level, the Federal End User Common Line Charge will apply at a ratio of five (5) per DS-1.

B. PUBLIC TELEPHONE SERVICE

- 1. A public telephone is an exchange station installed at the Company's option, equipped with a coin collecting device, at a location chosen or accepted by the Company as suitable and necessary for furnishing service to the general public.
- 2. Persons with whom arrangements are made by the Company for the installation of public telephone are considered agents of the Company in serving the public.
- 3. Public telephone are installed upon the agent signing established forms of application, without specific term, terminable by either the agent or the Company upon written notice.
- 4. No listings in the directory are allowed in connection with Public Telephone Service
